



M&A REVIEW ON HVACR

M&A Environment

We saw a pull back in 2023 compared to 2021 and 2022 driven by pent-up demand following the pandemic shutdown. However, 2023 was largely in line with the pre-pandemic years of 2018 and 2019.

Drawing from our experience and discussions with buyers/investors, we anticipate that we will see an uptick in transaction activity in 2024. There is a sense that more deals are being marketed, while private equity firms continue to raise larger funds and establish product specific HVACR platforms, which bodes well for sellers. Strategics will continue to scour the globe for companies that provide enhanced customer, supplier, product, and service diversification. M&A will continue to be influenced by two major themes underpinning the industry – environment sustainability and indoor air quality.



While we do expect the global economy to remain dynamic, the service, maintenance, and remodeling of the residential or commercial installed base should continue to grow as the market is driven by non-discretionary replacement demand and will continue to benefit from strong secular tailwinds including an aging housing stock, shortening replacement cycles, and favorable regulation. The new construction market should improve in 2024 as inflation recedes. This environment presents opportunities for larger industry incumbents and financial sponsors; their operational and financial capabilities can help companies come out ahead. The value stemming from timely consolidation will accrue to both buyers and sellers.

It is critical for sellers to understand that sophisticated buyers/investors focus on key operating characteristics, including strength and depth of the team, product and service offering, customer/supplier mix, distribution capabilities, reputation, and brand awareness when analyzing potential acquisitions. Businesses with strong, growing operations that fit this buyer/investor criteria are attractive, well positioned, and should have no shortage of options when considering a potential transition for their companies — be it an outright sale to a strategic buyer or a newly-formed partnership with a financial investor.



Performance of Publicly Listed HVACR Companies

Our conviction remains the same: public companies will continue seeking acquisitions of differentiated product and service companies within the HVACR space to bolster organic growth. Across the industry, the Q4 2023 Enterprise Value/EBITDA median multiple increased almost 25% compared to Q4 2022.
